

#### **ABSTRACT**

Land Acquisition – Kancheepuram District – Cheyyur Taluk – Setting up of Ultra Mega Power project – Acquisition of 1047.24 acres of patta lands and alienation of 759.67 acres poramboke lands in Vedal and in other six villages – Further continuance of 27 special staff to attend the land acquisition work for the period of one year from 01.10.2017 to 30.09.2018 – Orders – Issued.

## ORDER:

In the G.O 1<sup>st</sup> read above, Government have accorded administrative sanction for acquisition of 1047.24 acres of patta lands and alienation of 759.67 acres poramboke lands (Total 1806.91 acres) in seven villages namely Vedal, Chithargadu, Gangadevankuppam, Cheyyur B, Vilangadu, Kokaranthangal and Paramankeni in Cheyyur Taluk, Kancheepuram District for setting up of Ultra Mega Power Project (4000 MW) by Coastal Tamil Nadu Power Limited.

- 2. In the G.O 2<sup>nd</sup> read above, the Government have sanctioned 63 posts to attend the land acquisition work for a period of one year or till necessity ceases whichever is earlier.
- 3. In the G.O 3<sup>rd</sup> read above, the Government have sanctioned continuance of the posts sanctioned in the G.O second read above for a further period of one year from 01.10.2015 to 30.09.2016 or till the necessity ceases whichever is earlier.

- 4. In the G.O 4<sup>th</sup> read above, the Government have sanction continuance of the posts sanctioned in the G.O third read above for a furperiod of one year from 01.10.2016 to 30.09.2017 or till the necessity cearwhichever is earlier.
- 5. The Additional Chief Secretary /Commissioner of Land Administratic his letter fifth read above has stated that for attending all the above works, staff strength sanctioned in the G.O. are required, but due to dearth of hands Special Deputy Collector (LA) at Kancheepuram and unit offices at Cheyyur functioning with 8 posts as against the total strength of 23 posts. The process the acquisition of land have not yet been completed and only 75% of the has been completed and remaining 25% of work is pending and have to completed and has also furnished the concurrence letter from UMPP for continuance of Special Staff for the period from 01.10.2017 to 30.9.2018 details of the establishment charges. The Additional Chief Secreta Commissioner of Land Administration has recommended for retention Special Staff (field level -19, Collectorate -4, CLA office 4) for setting up of Mega Power Project, Cheyyur for a further period of one year from 01.10.20 30.09.2018

The Government after careful examination, accept the proposal Additional Chief Secretary / Commissioner of Land Administration and a sanction for further continuance of the following special posts for a further of one year from 01.10.2017 to 30.09.2018 or till the necessity ceases the whichever is earlier:
