- A. If any of their claims are found to be false or incorrect, their provisional admission to Oral Test / Certificate Verification and Oral Test will be cancelled and they will not be admitted to next stage of selection

The Candidates who have been admitted provisionally to the Oral Test /Certificate Verification and those candidates are hereby advised to attend the oral test with all the relevant documents, original without fail. The Candidates will be barred to proceed to the next stage on failure to produce the necessary/essential documents as instructed/required by this office.
- D. The mere inclusion of the register numbers of candidates in the above list will not imply that his/her candidature has been fully considered for next stage of selection.
- E. The candidates whose register numbers are found in the above list are only admitted provisionally to the Oral Test / Certificate Verification and the Candidates were provisionally admitted for 'Oral Test' are based on the marks obtained by them in the Preliminary Examination and Written Examination.
