ORDER:

In the G.O's first and second read above consolidated guidelines specifying the terms and conditions for the grant of centralised permission for the use of public Right Of Way (ROW) by any private or public sector applicant proposing to lay Optic Fibre Cables (OFCs) in Tamil Nadu were issued. In the G.O third read above Policy guidelines for taking up Maintenance and Last Mile Connectivity work were issued.

- 2. In their letters cited fourth , fifth and sixth above, Additional General Manager (ULDC/Telecom), Power Grid Corporation of India Limited, Southern Region –II had sent proposals seeking centralised permission of the Government for use of the public Right Of Way (ROW) in Tamil Nadu to lay OFC for the purpose of building Optic Fibre Network in a phased manner. Power Grid Corporation of India Limited has accepted all the terms and conditions prescribed in the G.Os read above and indicated that the entire cost of their respective projects will be met by themselves.
- 3. After careful examination of the above proposal by the Government in Information Technology Department, Municipal Administration & Water Supply Department and the Highways Department the Government decided to accept the request.
- 4. Accordingly, the Government hereby grant centralised permission to Power Grid Corporation of India Limited for use of the public Right Of Way (ROW) in Tamil Nadu for laying OFC subject to the following:
- a) Applicability of general terms and conditions prescribed in the G.Os read above and the amendments that may be issued from time to time.
- b) Each of the proposed network of the applicant will cover substantial parts of Tamil Nadu in addition to linking the Tamil Nadu network with the National Network being created by them.

- e) That the proposed network of the company should cover every District Headquarts in the State indicated in their proposal and provide access to every Block, Taluk an other administrative Headquarters of the State along which the OFC is likely to pass In the December 1988 to the D
- d) That the applicant has to verify the figures on number of Kilometers of cabling in the National and State Highways and in the Municipal Corporations since large stretche of State Highways have been reclassified as National Highway
- e) That any change in policy with respect to payment of Annual Track Rent, if any, i future will be made applicable to the applicant.
- Applicant shall follow 'trenchless excavation method' while laying OFC in the roads falling in the urban areas.
- Power Grid Corporation of India Limited is advised to initiate further action and keep the Government in Information Technology Department, Municipal Administration & Water Supply Department and Highways Departments informed of the progress in implementation of their project through detailed fortnightly reports.
